1. Call to Order/Roll Call: The Chair, Mr. Albert Montejano, called the meeting to order at 7:31 a.m. Roll call was taken.
2. Approval of Agenda: It was *M/S/C Romero/Peterson* to approve the agenda as published.
3. Approval of Minutes: It was *M/S/C Walsh/Peterson* to approve the October 5, 2009 minutes.
4. Public Opportunity to Speak: None.
5. Discussion/Possible Action Agenda:
  - a. LVN Program/Participant Support: It was *M/S/C Peterson/Romero* to approve supporting the Merced College LVN Program by providing supportive services to the participants. The above motion was amended by *Walsh/Newvine* to state the amount of supportive services would not exceed \$80,000, and forward to the Workforce Investment Board (WIB) for ratification.
  - b. Green Works Forum: It was *M/S/C Glass/Peterson* to approve acting as a convener along with Merced College for a Green Works Forum, and forward to the WIB for ratification.
  - c. Workforce Investment Board Strategic Scorecard: It was *M/S/C Walsh/Romero* to have both the Economic Development and Quality Employment Development Committees review the Strategic Scorecard to determine which Measurement Category would be applicable to each committee, and bring the recommendations to the Executive Committee for approval.

  - b. Grant Participation Outcomes: Staff noted neither the CA Clean Energy Grant nor the Pathways out of Poverty Grant were submitted. The Department has begun the New Start Grant that is for State parolees. It is a collaboration with several community partners who work with this population.

Ms. Andrea Baker noted the Dept of Corrections would be providing additional funds in the amount of 8.5 million dollars to all One-Stops in the State to help parolees get back into the workforce. Also, the Department is working with Merced College to improve the joint grant application process. There is now a process in place for those grants that will be worked collaboratively.

1) Workforce Investment Board Recruitment – Business Sector: Mr. Steve Newvine noted the WIB needs over 50% membership from the business sector, and the committee has been identifying potential members for the WIB. A list has been developed, and staff will be contacting those on the list.

**SUBJECT: Programmable Logic Controller Training – Rexel, Inc**

**PROPOSED MOTION(S):** Recommend course offerings in the field of Programmable Logic Controller (PLC) through Rexel, Inc, to serve incumbent workers from Merced County Manufacturers for the period January 1, 2010 through June 30, 2010, at a cost not to exceed \$83,950, and forward to the Board of Supervisors for approval.

**DISCUSSION:** This training is proposed based on local employer need and request. This skill-building course offered by Rexel, Inc, will provide the practice needed to interpret, isolate and diagnose common hardware problems related to noise, power, discrete and analog Input and Outputs (I/O) for PLCs. Additionally, these courses will introduce participants to ladder logic interpretation as they are applied to diagnostic tasks, and advance troubleshooting and manufacturing processes. Participants will receive “student manuals” comprised of a PL5/SLC 500 Procedures Guide (the preferred PLC with majority of Merced County Manufacturers), as well as Reference and Troubleshooting Guides related to the trainings. This contract will run from January 1, 2010 through June 30, 2010 at a total contract cost not to exceed \$83,950.

This sole source agreement is based on a Federal Government sole source agreement with this vendor. Rexel instructors will provide two four-day courses to include a combination of PLC-5 and RSLogix 5 Maintenance and Troubleshooting as well as SLC 500 and RSLogix 500 Maintenance and Troubleshooting and Fundamentals (two-day course) for up to 40 participants.

Incumbent Worker Training is designed to provide assistance to qualifying Merced County for-profit manufacturing companies to provide skills training to full-time, permanent company workers. These employers are critical to the economic competitiveness of California’s economy. The training will enhance companies’ abilities to keep up with global economies, expand present markets, and help ensure the permanency of businesses in Merced County. For the workers, the training will upgrade present work skills, heighten job security, provide marketable skills, and increase the possibilities for higher wages and promotional opportunities while simultaneously increasing the possibility that job openings left by incumbent workers would be filled by Merced County jobseekers.

**SUBJECT: Virtual One-Stop Subscription – Geographic Solutions**

**PROPOSED MOTION(S):** Recommend contract with Geographic Solutions for a Virtual One-Stop subscription (VOS) to provide an electronic case management system and job spidering tool for the period January 1, 2010 through December 31, 2010, at a cost not to exceed \$62,200, and forward to the Board of Supervisors for approval.

**DISCUSSION:** This internet-based subscription provides universal access to online services for individuals seeking jobs, training, resume information and other program information. The subscription also offers unique tools for employers looking to recruit talent and assess the labor market. The VOS subscription is specifically designed to provide services for staff and One-Stop operators, automating the case management flow and increasing efficiency when providing assistance to businesses and jobseekers. Key features include core and intensive services including unique access to reporting features (used for Workforce Investment Board and State reporting), which increases the amount of information needed for improvements of service delivery and ensures performance is being met by Workforce Investment.

Neighboring counties including Madera County and the Mother Lode Consortium utilize the VOS system. Using the same system will ensure a smooth transition for Merced County residents that are co-enrolled in regional projects across these counties. Approval to utilize a Request for Proposal (RFP) let by the County of Santa Barbara in July 2009 has been secured in order to satisfy the competitive RFP process needed to secure the VOS subscription. Additionally, VOS provides current State Labor Market Information (LMI) data, and has job spidering integrated for LMI as well as jobseekers.

**SUBJECT: Ad Hoc Committees' Responsibilities**

**PROPOSED MOTION(S): That the Executive Committee define the roles of the Quality Employment and Development Committee and the Economic Development Committee.**

**DISCUSSION:** There are currently two ad hoc committees with duties and responsibilities that occasionally overlap. It is necessary to define the goals and function of each committee so there is not a duplication of efforts. The Economic Development Committee was developed to adhere to the Workforce Investment Act that mandates that local Workforce Investment Areas coordinate their activities with economic development strategies in that area. Given the changing economic climate, new legislation and current uncertainties of future strategies, it may be necessary to redefine the role of this committee. There may be a need to expand the scope of the committee as well as narrowing and/or defining the specific functions of the committee.

The Quality Employment and Development Committee was developed and expanded from the previous Recertification Ad-Hoc Committee. While the recertification of our One-Stops was successfully achieved for a three-year period, it is an ongoing commitment towards improvement. As of late, the committee has been reviewing potential grants, performance measures, participant numbers, customer satisfaction surveys, certain policies, and other projects as they arise.

There has been some overlap and uncertainty on the duties that each committee has been assigned or undertaken. There is a need to define their functions to alleviate these uncertainties and overlaps.

**SUBJECT: WIA Fiscal Reports**

**PROPOSED MOTION(S): None. Information Only.**

**DISCUSSION:** Attached is the Fiscal Report for Fiscal Year 2009/10 covering July 1, 2009 through October 31, 2009. This report shows all WIA funds available for Fiscal Year 2009/10, accrued expenditures through October 31, 2009, and obligations as of October 31, 2009. Target for expenditures is 33.33%, and as of October 31<sup>st</sup>, accrued expenditures were at 21.07% of available Adult Formula Funds, 22.04% of available Dislocated Worker Formula Funds, and 33.72% of available Youth Formula Funds. Youth funds are at a higher percentage due to expenditures from FY 08/09 billed in FY 09/10. Other grants are at different percentages due to different grant timelines.

Also included is the Fiscal Report for the Recovery Act Funds (ARRA). This report shows all funds available since the beginning of the ARRA funding and all expenditures against these funds. The majority of ARRA Youth Funds have been spent, on target with directions from the Department of Labor and the California Employment Development Department. Enrollments in Adult and Dislocated Worker ARRA funds are increasing. The ARRA Green Jobs program is underway.

Also attached is the Contracts Report showing FY 09/10 accounts receivable contracts, with invoices received and payments made through November 30, 2009. This report shows the total contract amounts, payments made, and includes the date of the most recent invoices received.

Fees received for Enterprise Zone Vouchers from July 1, 2009 through November 30, 2009 are \$84,540 plus an additional \$14,090 collected on behalf of the State for their fees.

Staff will be present at the meeting to answer questions.

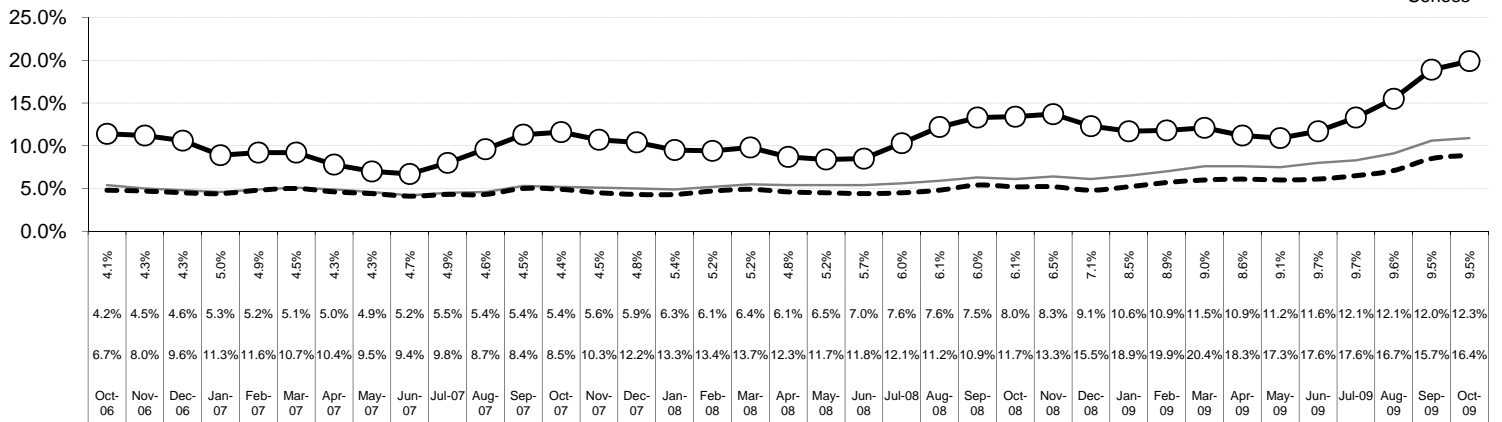
The County continues with one of the highest unemployment rates in the State, ranking 51st out of 58 counties in the month of October. The preliminary result is an increase of .9 percentage points in the unemployment rate from the September rate. For year ago data, this preliminary figure is an increase of 4.9 percentage points in the unemployment rate.

Overall, the County's Civilian Labor Force was unchanged over last month's figure and an increase of 1,500 persons over year ago figure. Industrial employment decreased by 200 jobs in October over September's figure and an decrease of 2,200 jobs over year ago's figures.

### Merced County, California, and the United States Unemployment Rate October 2006 to October 2009

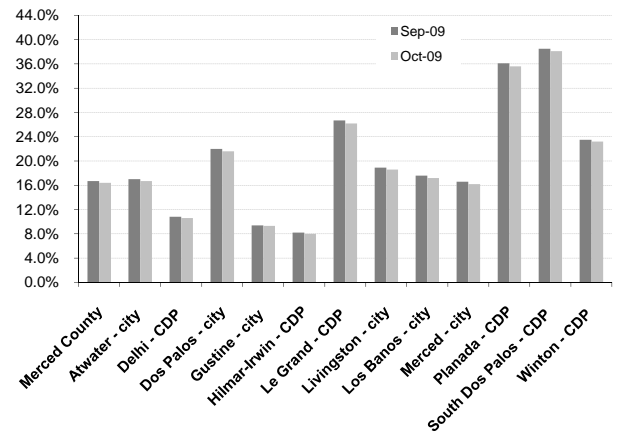

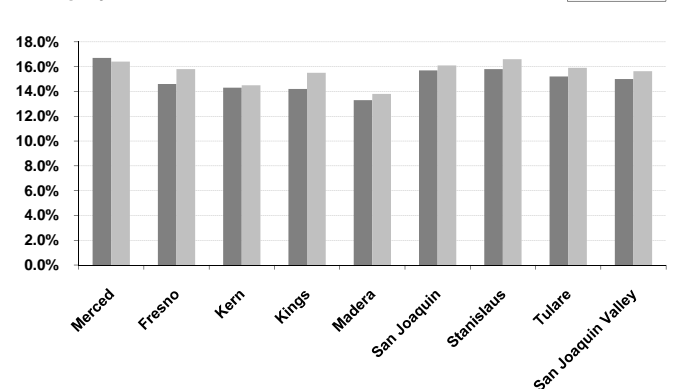

**DISCUSSION: On, July 16, 2009, the Merced County Department of Workforce Investment was a subrecipient of State funding in the amount of \$40,109.00 with contract period beginning June 30, 2009 and ending June 30, 2010. Future funding was contingent upon the availability of federal funding.**

**Since that time, on October 23, 2009, a paper was submitted to California Department of Corrections and Rehabilitation detailing how funding would be utilized to serve parolee clients. On November 18, 2009, Merced County Dept of WI received a modification adding additional funds in the amount of \$60,499.00 for the period beginning October 1, 2009 and ending September 30, 2010.**

**The purpose of these funds is to enhance employability of parolees and their access to employment opportunities. These funds are intended to improve the vocational aptitude of offenders while in custody, and increase the likelihood of them securing employment upon release from prison. In addition, California New Start will be vital in reducing prisoner recidivism and improving parolee reintegration by providing employment opportunities.**

**DISCUSSION:** A grant proposal has been submitted by the Central California Workforce Collaborative (CCWC—a 14 county partnership) to the California Workforce Investment Board. The counties involved in the collaborative are Amador, Calaveras, Fresno, Inyo, Kern, Kings, Madera, Mariposa, Merced, Mono, San Joaquin, Stanislaus, Tulare and Tuolumne.
