SUBJECT: WIB Recertification

PROPOSED MOTION(S): Review WIB Membership and actively recruit the desired private sector members.

DISCUSSION: State Directive WIAD02-5 communicates the policy and procedure regarding recertification of Local Workforce Investment Boards (LWIB). One of the requirements is to ensure that the appointment and composition of each LWIB is consistent with the criteria in WIA Section 117(b). A list of the WIB membership is due to the state by October 31, 2002.

Currently there are 19 private sector and 19 public sector members. There will be 21 private sector members (with the appointment of Scott Galbraith and Albert Montejano) and 20 public sector members (with the appointment of Lee Anderson).

While the WIB would be in compliance with the addition of the new members upon BOS appointment, there is an application pending for another education member. This person cannot be considered until there is another private sector individual on board. It is important to ensure that we have the required number of private sector representation before bringing on any more public sector.
