The purpose of the program is to empower parents to become more effective in their parenting by clarifying their rights and responsibilities and their children's rights and responsibilities.

- To inform parents and children as to their rights and responsibilities as citizens and families in the courts and justice system
- To inform parents as to services available to families in this community

- Approximately 25 youth start work next week.
